Obligation to prepare and publish statement in accordance with paragraphs 9-10 of standard condition 38 (Treatment of payment claims for last-resort supply) of the Electricity Distribution Licence

1. Revenue recovered from the consequential increase in Use of System charges

In accordance with paragraph 2 of SLC38 of the Electricity Distribution Licence Use of System charges were increased in the Relevant Regulatory Year to such an extent the licensee reasonably estimates is appropriate to ensure that the consequential increase in its Use of System revenue will equal the Specified Amount in Co-operative Energy Limited's Last Resort Supply Payment claim. On 6 February 2018 Ofgem provided the necessary derogations¹ to allow DNOs to recover Co-operative Energy Limited's claim, via a supplementary increase of 0.08 pence per day to the domestic unrestricted, domestic two rate and LV network domestic tariffs.

2. Last Resort Supply Payments made in response to a Valid Claim to the Claimant

In accordance with paragraph 3 of SLC38 of the Electricity Distribution Licence during or as soon as practicable after the end of the Relevant Regulatory Year, the licensee must pay the Claimant in instalments as specified in the Valid Claim the amount of the consequential increase in its Use of System revenue, to the extent that it does not exceed the Specified Amount.

3. Excess/(shortfall) use of system revenue recovery

In accordance with paragraphs 4 and 5 of SLC38 of the Electricity Distribution Licence, if the amount paid to the Claimant is different to the amount of the consequential increase in Use of System revenue, the licensee must vary its Use of System charges in the year following the Relevant Regulatory Year to recover/return the difference plus 12 months' interest on that amount. In the event of a shortfall the licensee must also pay the Claimant the amount plus 12 months' interest on that amount.
