

UK Power Networks Christmas Lights Competition Terms and Conditions

1. Eligibility: The UK Power Networks Christmas Lights promotion (the "Competition") is open to Facebook, Twitter and Instagram users aged 18 or over (the "Participants") and runs from 12.01am BST on 29th November 2013 until midnight GMT on 13th December 2013 with a winner being announced 16th December.

2. The promoter of the Competition is UK Power Networks (Operations) Limited (the "Promoter").

3. This Competition is not open to the employees of the Promoter or their immediate families, or any of the Promoter's contractors or any person directly or indirectly involved in the Competition.

4. The Competition prizes (the "Prizes") shall consist of the following:

5 x Christmas hampers to the value of £60 each.

Each winner will be awarded 1 Christmas Hamper to the value of £60 and will be dispatched within 7 days of announcement of competition results. ("Prize").

6. Automatic entry into the Competition will occur when a Participant posts an image on the UK Power Networks Facebook wall, on the @UKPNnews Twitter account using the hashtag #UKPNxmaslights or shares via Instagram.

7. The judge's decision in selecting the finalists and winners is final and no correspondence will be entered into.

8. The winners will be contacted through the social network they used to submit their entry. These notifications will be sent during the seven day period following the end of the Competition

9. If a winner of a Prize cannot be traced after reasonable efforts have been made by the Promoter, that winner will forego the right to claim the Prize and the Promoter will arrange for a replacement winning entry to be selected

10. The Prizes are non-transferable, non-refundable and non-changeable. Cash or credit alternatives for the Prizes will not be offered

11. The Promoter reserves the right to provide an alternative prize of similar value should the specified Prize(s) become unavailable for any reason beyond the Promoter's reasonable control

12. The Promoter may include your photo and your name on Twitter, Facebook and the Competition-related part of the Promoter's website (www.ukpowernetworks.co.uk/xmaslights) ("Our Website"). Note, however, that we have no obligation to include any entry on Twitter and Facebook and will be entitled to withdraw any entry at any time without notice to you.

By submitting any photograph as an entry in our Competition, you undertake that it is (a) your original work, and not a copy of any other work (or any part of another work), (b) not infringing of anyone else's rights, such as by being defamatory; (c) legitimately distributable by us, and viewable by users of Our Website of all ages; (d) not considered obscene if presented to persons of any age; (e) otherwise entirely legally compliant; and (f) not offensive in its content.

14. You will continue to own the copyright (if any) in your entry. However, by submitting it you irrevocably license us with full title guarantee to make such use of your entry as is referred to in these terms & conditions

Any personal data which you provide will be held and processed in accordance with the requirements of the Data Protection Act 1998.
